



Automotive M&A Count Across the U.S. (2000 – Jun'2022)




U.S. Automotive M&A Count (2000 – Jun'2022)



Median Transaction Value (2000 - Jun'2022)




Median EV Multiples (2000 – Jun'2022)






Relative Stock Performance (2012 – Jun'2022)
