



#### Automotive M&A Count Across the U.S. (2000 – Mar'2023)




# U.S. Automotive M&A Count (2000 - Mar'2023)



### Median Transaction Value (2000 - Mar'2023)




# Median EV Multiples (2000 – Mar'2023)
