

Industrials & Manufacturing M&A Count Across the U.S. (2000 – Mar'2023)




U.S. Industrials & Manufacturing Count (2000 – Mar'2023)



Median Transaction Value (2000 - Mar'2023)




Median EV Multiples (2000 – Mar'2023)
