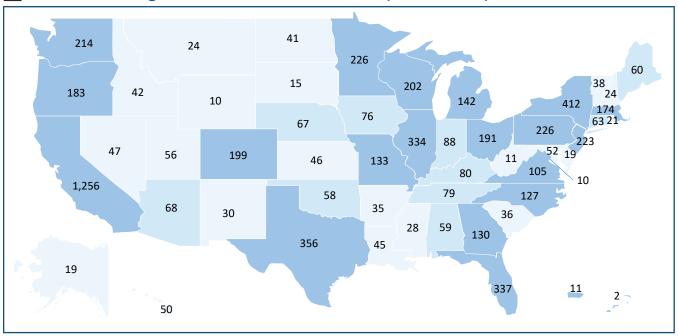

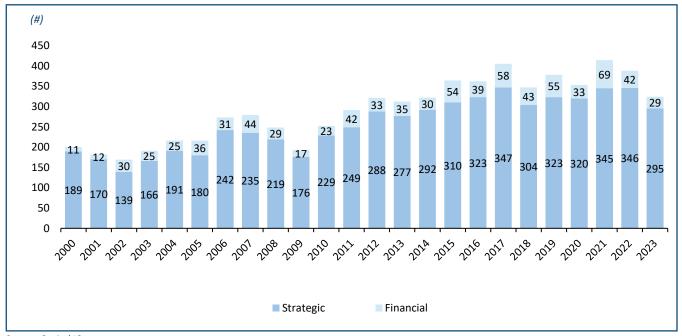

U.S. Food & Beverage M&A Count (2000 – 2023)



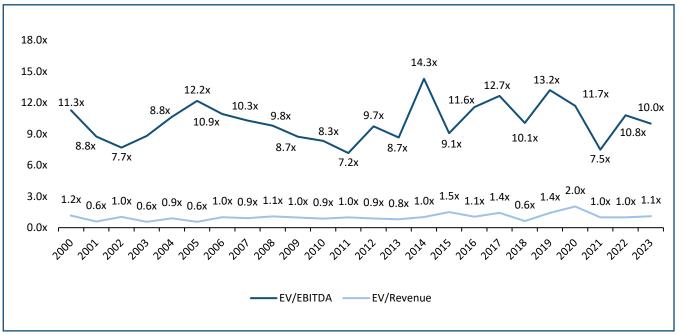

Median Transaction Value (2000 - 2023)



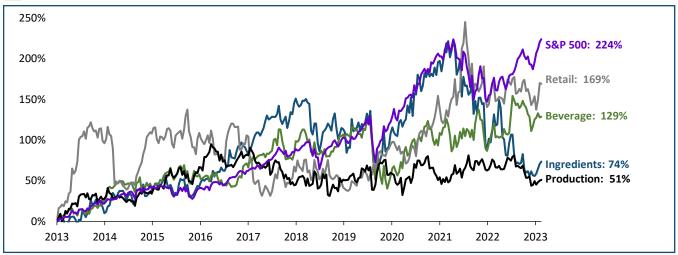
Median EV Multiples (2000 – 2023)



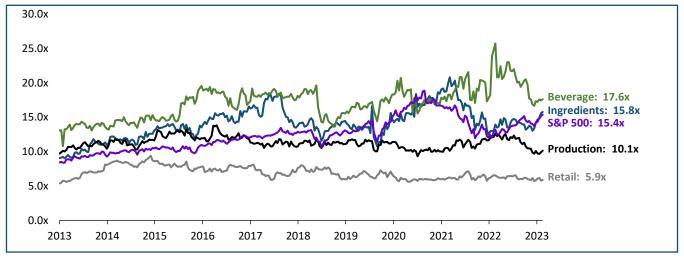

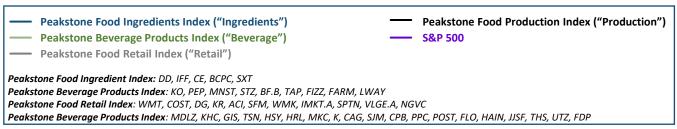
Relative Stock Performance (2013 – 2023)
