

Transportation & Logistics M&A Count Across the U.S. (2000 – Jun 2025)




U.S. Transportation & Logistics M&A Count (2000 – Jun 2025)



Median Transaction Value (2000 - Jun 2025)




Median EV Multiples (2000 – Jun 2025)
