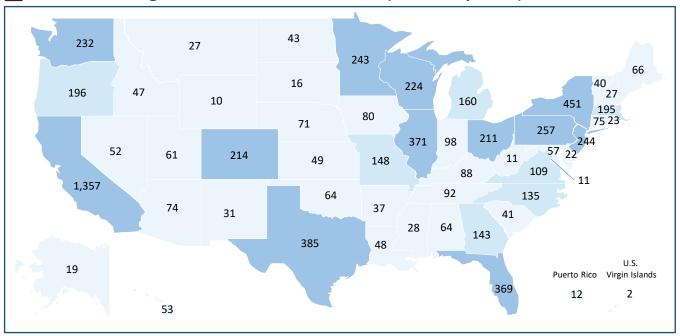

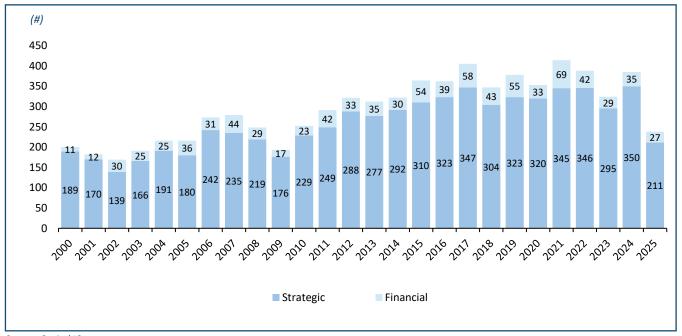

U.S. Food & Beverage M&A Count (2000 – Sep 2025)



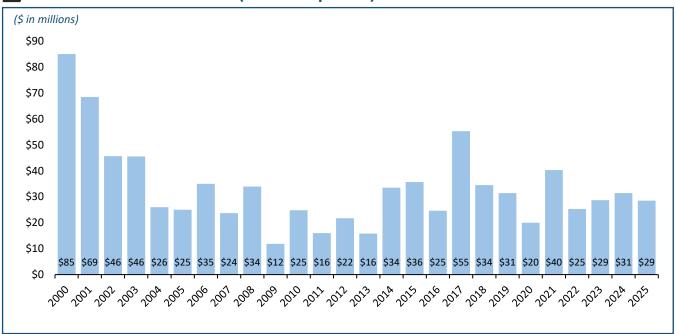

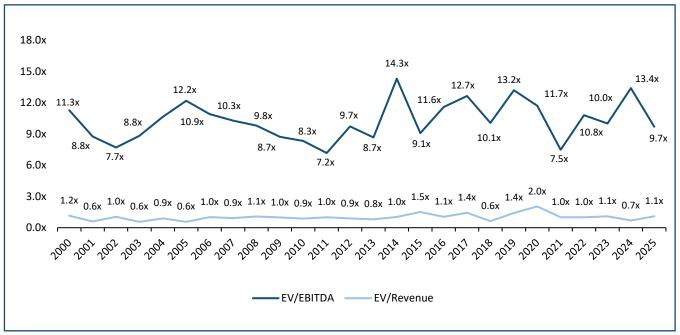

Median EV Multiples (2000 - Sep 2025)



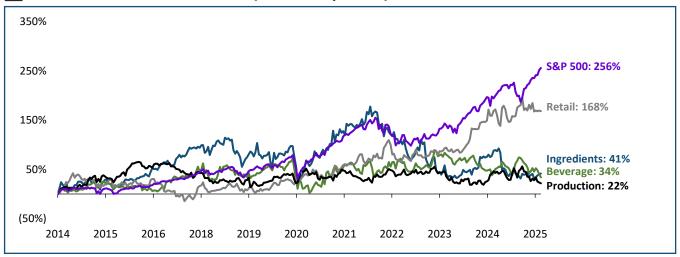

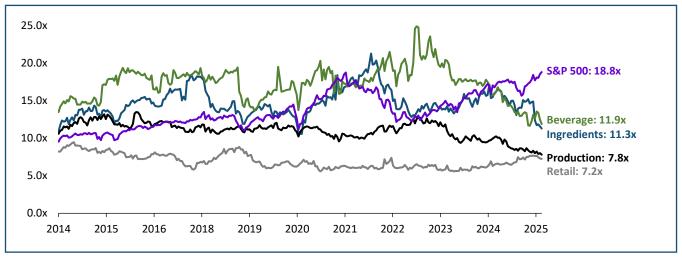
